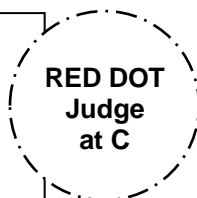

18	Driver	Use of aids, handling of reins, whip and voice. Driver's position. Preparation for movements.
